# Assessments and Individualised Therapy

# Full Assessment Session (face to face) - £175

A full assessment session to gain a thorough understanding of your child's communication strengths and needs. This typically meets the needs of children with less complex communication difficulties, for example 'late talkers', children who stammer or who have speech sound difficulties.

- The session will take approximately 1 hour
- Includes full case history
- · Includes the use of informal and formal assessment, when required
- Verbal feedback and next steps agreed
- Includes one page summary report

# Comprehensive Assessment Session (face to face) - £400

For some children a longer assessment will be required. These children are likely to present with communication difficulties which may be subtle or complex, that are having a significant impact on a number of aspects of their life (for example being able to access class teaching, understanding and coping with feelings, forming and maintain relationships) or they may have additional medical needs. This is also a useful option when requiring supporting evidence for a detailed report for education settings.

- · The session will take up to 2 hours of face to face time
- Includes full case history
- Includes use of informal and formal assessment
- Information gathering through liaison with other professionals, for example SENCo or class teacher, Educational Psychologist
- Verbal feedback and next steps agreed
- Detailed report, including implications for access to education and activities of daily life

# **Online or Phone Assessment Session - £99**

An opportunity to fully discuss your child's communication strength and needs, and to receive some suggestions of how to support them while social distancing measures remain in place.

- · Up to one hour split over two sessions
- Includes full case history
- Send me videos to watch
- Verbal feedback and next steps and/or ideas of how to support your child agreed

# Therapy Session - £77

Individualised therapy sessions with Kate, based on your child's communication strengths and needs, supporting them to meet their communication potential through achieving short term goals which we will agree together in advance.

- 30-45 minute session
- Therapy sessions will provide you with a range of activities to support your child to meet their goals
- Activities will be carried out 1:1 and modelled to parents to ensure effective practise at home

# Online or Phone Consultation - £60

An opportunity to discuss your current concerns and find out if Speech and Language Therapy is required, and if Kate would be a good fit to work with you and your family. This is also useful for parents/carers who don't have significant concerns, but would like the opportunity to discuss their child's communication and gain ideas of how to further support their child.

- Up to 30 minutes
- Verbal feedback and next step suggestions

If you book a full assessment session with We Can CommuniKate after an online or phone consultation, the cost of the consultation will be removed from the assessment cost.

#### Consent

By attending an assessment or therapy session, you consent to the session taking place and the SLT (speech and language therapist) taking notes throughout the session as required.

#### Data

For each child, We Can CommuniKate will keep up to date personal data. This will include identifying information such as name and date of birth, as well as a record of each session with We Can CommuniKate including assessment results and reports.

All data is kept on Write Upp. This is fully GDPR compliant and uses two factor authentication log in to ensure your data is kept securely. Data will be kept for 7 years after our last contact, at which point it will be deleted and videos, when used, will be deleted at the end of each block of therapy. We Can CommuniKate SLT is registered with the Information Commissioner's Office. Upon request, all data will be deleted immediately.

Information may be shared via email or what's app (for videos) with parent/carer's permission. This is done so at the parent/carer's risk and We Can CommuniKate does not take responsibility for the safety of sharing data this way.

# Safeguarding and Child Protection Policy

I have a duty to protect the children that I know and are on my caseload. I have received training on Safeguarding Children and Child Protection and ensure that I access supervision regularly to ensure that any action I take is effective.

In the first instance, any safeguarding concerns will be discussed with parents/carers unless I believe that doing so puts the child at increased risk.

Typically, I prefer to work with children accompanied by another trusted adult - usually a parent in clinic or the child's home, or a teacher or learning support assistant within a school. In school, this is not always possible.

#### Fees

#### **Cancelling Appointments**

If you need to cancel or reschedule an appointment please provide a minimum of 48 hours notice, though more is appreciated. Failure to provide this notice will result in a 50% charge which must be paid before the beginning of the next session.

#### **Deposit for Assessment**

A £50 deposit is requested to secure all first assessments. This will be deducted from the final price of the assessment. If a session is cancelled or postponed within 5 working days of the scheduled appointment, then an additional deposit is required and the initial deposit is not refunded.

#### Supervision

In order to ensure the very best practice, supervision often takes place between therapists. All client information is kept confidential.

#### Consultations

Please note, that during consultations we will make recommendations based on the information you provide us. As a therapist, we will use our clinical knowledge to ask the relevant questions to understand your child's communication skills as much as possible - however, we can only do this if you provide us with accurate and full information.

# Participation

It is expected that parents will participate during therapy sessions in order to facilitate practise at home.

#### **Termination of Therapy**

The parent/carer and the SLT have the right to end therapy services at any time.
